

Locum Delegation Important tips for adding a locum to your EMR

In recognition of a physician's need to provide continued patient care during their absence, TELUS Health allows physicians to share their EMR subscription for a period of time during their absence through the creation of a locum subscription. To learn about who is considered a locum, what a locum can do under locum subscription and how to setup and delegate a new locum account, visit the Help Files and search 'Locum Delegation.' In this Help File, there is also important information about what a provider can still do with a locum in place. For example, physicians still have the ability to review results.

MCP Billing Update Correct codes and fees now in the EMR

eDOCSNL recently experienced technical issues with uploading the 2019 MCP Payment Schedule that came into effect on October 1, 2019. Canada's national e-prescribing service, PrescribeIT® is coming to our province.

PrescribelT® makes prescribing easier and more convenient for Canadians, prescribers and pharmacists. It also improves patient safety and health outcomes, and protects patient privacy.

PrescribelT® integrates seamlessly with Med Access and allows the prescriber to transmit a prescription from the EMR directly to the pharmacy management system of a patient's pharmacy of choice. That's much more convenient and safer than paper prescriptions that can get lost or forgotten, or faxed prescriptions that can go to the wrong place, resulting in privacy breaches.

Secure electronic transmission means prescriptions arrive at the pharmacy before patients do saving time for patients. The service also improves communication between prescribers and pharmacies, reduces prescription errors, and lessens the risk of forgery and fraud, especially for narcotics and other controlled substances.

Managing Allergies Important functions inside the allergy window

When you add an allergy or are managing allergies in your EMR, it is important to know the functions of the four buttons inside the 'Allergy' window. This includes:

- Update: used to add an additional fact to an existing allergy profile item.
- **Correct:** used for the correction of an allergy; indicates that the allergy has been corrected.
- **Refute:** should be used when the patient identifies allergies, has subsequent testing and the allergy is found to be untrue. The allergy will appear greyed out but will still be present in the allergy profile.
- **Cancel:** completely deletes the allergy from the patient's allergy profile.
