# What's New in HEALTHe NL?

April 2023

## Advance Health Care Directive

Please be advised that effective April 11, 2023, providers will be able to note if a patient has an Advance Health Care Directive (AHCD) in HEALTHe NL. The AHCD will be included on the Demographics panel of the Patient Summary page including whether the patient has an AHCD and the location where the AHCD details may be found.

When the patient has an AHCD on file in HEALTHe NL, the indicator is set to **YES** and the location will be displayed. Otherwise, **UNKNOWN** is displayed, including when a previous AHCD record has been deleted.




