

eDOCSNL ENROLLMENT ¹ AND OTHER FEES - FFS

Monthly Subscription Cost

Nurse Practitioner	\$200/month	Nurse Practitioner enrollment allows up to 5 additional staff (i.e. nurse, admin, etc).
NP's Staff User (>5 per NP)	\$80/month	Applied when a Provider has more than 5 staff members. Additional staff are subject to the associated costs to be paid by the Provider or Clinic.
Allied Health Professional	\$145/month	Additional users classified as Allied Health Professionals are subject to the associated costs to be paid by the AHP, Provider, or clinic.

One time Enrollment costs covered by program

Physician/Nurse Practitioner	\$4,000.00	Physicians and Nurse Practitioners are required to participate in formal training facilitated by a Telus Learning Specialist and EMR Program Staff. This is a per provider cost.

Ongoing costs covered by program

Physicians	\$200/month	Physician subscription fee. Enrollment allows up to 5 additional staff (i.e. nurse, admin, etc).
Part-Time Physician	\$200/month	Physician subscription fee. Enrollment allows up to 5 additional staff (i.e. nurse, admin, etc).
Physician's Staff User (>5 per MD)	\$80/month	Applied when a Provider has more than 5 staff members. Additional staff are subject to the associated costs to be paid by the Provider or Clinic.
Mobile License	\$50/month ²	Additional \$50.00/mo per provider is covered for Providers (MD & NP) who work in more than one Instance.

Other Services

Additional training by Telus	\$1200/day	Full day session. Maximum of 6 users per onsite session and 4 user maximum for virtual sessions.
After hours training by Telus	\$75/hr	eDOCSNL will pay \$150/hr for Telus training on request, after hours training will be charged to the program at the rate of \$225/hr, the additional \$75/hr will be charged to the clinic.
Customs forms and templates created by Telus for the purpose of distribution to all users	\$600/page	Telus will build forms for clinics that are not paid for by eDOCSNL, as detailed in the eDOCSNL forms policy ³ .
Customs forms and templates created in an individual instance of the EMR by Telus	\$150/hr	Any custom content created by Telus for use within an EMR instance, above and beyond that which would be normally considered reasonable for an implementation or post-go live.
Data conversion - extract from an instance	\$1,500	Provider movement necessitating movement of EMR data will involve a cost to the provider.
Data conversion - import to an instance	\$1,500	Provider movement necessitating movement of EMR data will involve a cost to the provider.
Provider movement	\$500	Provider movement from one instance to another, or being added to another instance while maintaining their practice in their current instance ⁴

¹ Enrolment occurs when a Physician signs the eDOCSNL Participation Agreement becoming a part of the program.

² Telus charges the program (\$50.00 per month per provider) additional fees for Providers and Nurse Practitioners who work in more than one instance. At this time the Management Committee has decided not to pass these costs on to providers. This decision may be revisited in the future and Providers in this scenario may incur additional charges.
